- ★ **Bulls** need to hold above yest closes **6646 and 24403-- long above these**
- ★ Breakouts are above yesterday's highs **6680 and 24550- aggressive longs** (await for confirmation with a new high and a retest of the highs from above that holds)
- ★ **Bears** need under overnight lows **short under 6582 and 24193**
- ★ Breakdown is below yest lows **6483 and 23772 -- aggressive shorts** (wait for confirmation with a new low and a retest of the lows from below that hold)
- ★ **RANGEBOUND: 2 Way trade long and shorts will work** to get the day done
- ★ Keep it simple and be patient for confirmation on either side or establish the range if we are going to be rangebound
- ★ Confirm rally continuation with sustained trade over the 30min IB High and likewise
- ★ bearish under the IB Low
